### PRE-PURCHASE DUE DILIGENCE

At the beginning of a BOLI purchase, BOLI Strategic Partners will conduct a comprehensive pre-purchase analysis. The overall analysis will address the nine major actions recommended by the Interagency Statement on the Purchase and Risk Management of Life Insurance, OCC Bulletin 2004-56<sup>2</sup>. With the completion of the analysis, BOLI Strategic Partners will document the implementation of the BOLI

purchase and, if applicable, nonqualified benefit plans in a comprehensive report (due-diligence binder). This report will document the steps taken during the implementation of BOLI and applicable nonqualified benefit plan (s).

Following implementation of your BOLI policies and any applicable nonqualified benefit plans, BOLI Strategic Partners will review accounting options for the BOLI programs and review it with your accountants. OCC Bulletin 2004-56 recommends that management review the performance of a bank's BOLI with its board of directors at least annually. The regulatory guidance recommends the various tests that should be addressed in management's risk review. Annually, BOLI Strategic Partners provides a "Post-Purchase Risk Assessment" of a bank's BOLI program on behalf of management. This report is a thorough review of the BOLI risks as detailed in the regulatory guidance. As part of the review, BOLI Strategic Partners is also available to review the report with key bank executives and the board of directors.
